

ABC13's 25 Days of Christmas Sponsored by Conn's Home Plus OFFICIAL SWEEPSTAKES RULES

The ABC13's 25 Days of Christmas Sponsored by Conn's Home Plus (the "Sweepstakes") is a sweepstakes in which three (3) Prize winners will be randomly selected from all eligible entries. Two (2) Prize Winners will each receive one (1) \$250 gift card to Conn's Home Plus and One (1) Prize Winner will receive one (1) \$500 gift card to Conn's Home Plus.

By participating in the Contest, each entrant agrees that all decisions regarding the Contest, including but not limited to, eligibility determinations, rules and rule interpretations, and the handling of technical difficulties or other errors are at the sole and exclusive discretion of Sponsor and are final, binding and not subject to appeal.

I. NAME OF SPONSORS: KTRK Television, Inc. and Conn's Home Plus ("Sponsor")

IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED: Three total (3) Prize Winners will be selected from a random drawing during the sweepstakes time period. The first \$250 Prize will be selected on or about Wednesday, December 11th, the second \$250 prize winner will be selected on or about Wednesday December 18th, and the third prize of \$500 will be selected on or about Thursday, December 26, 2019. All winners will be notified within 3 business days of selection day. Odds of winning depend on number of valid entries received. Final determination of winners is always conditional on verification of eligibility and compliance with all rules and procedures. The winners will be notified by telephone or e-mail. If a potential winner cannot be reached within Two (2) days of

notification of winning, or if he/she is found to be ineligible, or if he/she cannot or does not comply with these Official Rules, winner(s) will be disqualified and an alternate winner may be selected.
