

## **ABC13's 25 Days of Christmas Sponsored by Conn's Home Plus OFFICIAL SWEEPSTAKES RULES**

The ABC13's 25 Days of Christmas Sponsored by Conn's Home Plus (the "Sweepstakes") is a sweepstakes in which three (3) Prize winners will be randomly selected from all eligible entries. Two (2) Prize Winners will each receive one (1) \$250 gift card to Conn's Home Plus and One (1) Prize Winner will receive one (1) \$500 gift card to Conn's Home Plus.

By participating in the Contest, each entrant agrees that all decisions regarding the Contest, including but not limited to, eligibility determinations, rules and rule interpretations, and the handling of technical difficulties or other errors are at the sole and exclusive discretion of Sponsor and are final, binding and not subject to appeal.

**I. NAME OF SPONSORS:** KTRK Television, Inc. and Conn's Home Plus ("Sponsor")

### **II. ELIGIBILITY:**

- Entrants must be 18 years of age or older at time of entry and be legal residents of the United States who are physically located and residing in counties Harris, Fort Bend, Montgomery, Brazoria, Galveston, Liberty, Waller, Chambers, Austin, San Jacinto, Matagorda, Walker, Polk, Trinity, Grimes, Washington, Colorado, Wharton, Jackson and Calhoun in Texas ("Viewing Area").

From Wednesday, November 27, 2019 until 11:59 on Wednesday, December 25, 2019, ABC13.com registered members may enter online at ABC13.com.

**How to register:** You must be a registered member of [ABC13.com](http://ABC13.com) to enter.

- **Existing Member:** As a Member, you may enter the Sweepstakes by logging in to ABC13.com ("**Website**") with your user name ("**User Name**") or email address ("**Address**") and password and following the entry instructions. If you login to your Member account using Facebook, you will be asked to allow Facebook's "Basic App Permissions," which is required in order to login to your Member account and participate in the Sweepstakes.

**IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED:** Three total (3) Prize Winners will be selected from a random drawing during the sweepstakes time period. The first \$250 Prize will be selected on or about Wednesday, December 11th, the second \$250 prize winner will be selected on or about Wednesday December 18<sup>th</sup>, and the third prize of \$500 will be selected on or about Thursday, December 26, 2019. All winners will be notified within 3 business days of selection day. Odds of winning depend on number of valid entries received. Final determination of winners is always conditional on verification of eligibility and compliance with all rules and procedures. The winners will be notified by telephone or e-mail. If a potential winner cannot be reached within Two (2) days of

notification of winning, or if he/she is found to be ineligible, or if he/she cannot or does not comply with these Official Rules, winner(s) will be disqualified and an alternate winner may be selected. Prizes not claimed by January 3, 2020 at 5pm will be forfeited. To claim prize, (a) winners must provide proof of age, identity and residency, (b) winners must sign and return affidavit of eligibility/compliance with rules, publicity/liability release and indemnification all within time period specified by station.

- **Approximate retail value ("ARV") of Prize:** Prize Value is \$250 and \$500.
