

## **LA CHARGERS MEXICO TRIP 2019 SWEEPSTAKES - OFFICIAL RULES**

### **I. NAME OF SPONSOR(S)**

KABC-TV, ABC Holding Company Inc. (hereinafter referred to as "**Sponsor**").

### **II. ELIGIBILITY**

The Sweepstakes is open only to legal residents who reside in the Designated Market Area ("**DMA**") of KABC-TV, as determined by Nielsen Media Research Services, and who are at least eighteen (18) years of age or older at the time of entry. The DMA of KABC-TV covers the following counties: Inyo, Kern County-East, Los Angeles, Orange, Riverside County-East, Riverside County-West, San Bernardino, and Ventura counties in the State of California.

Any individuals (including, but not limited to, employees, consultants, independent contractors, and interns) who have, within the past six (6) months, performed services for Sponsor, other television and radio stations in the DMA, the Los Angeles Chargers, or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying a prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, and any person who, within the past ninety (90) days, has been awarded a prize in any sweepstakes conducted by Sponsor, are not eligible to enter or win. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three (3) months a year.

### **III. HOW AND WHEN TO ENTER**

#### **NO PURCHASE NECESSARY.**

The "**Entry Period**" for this Sweepstakes shall start at 11:00pm PT on **Monday, October 21, 2019** and end at 11:59pm PT on **Sunday, October 27, 2019** ("**Entry Period**").

#### **HOW TO ENTER:**

Viewers should watch *ABC7 Eyewitness News* at 11:00pm Pacific Time ("**PT**") beginning weekdays on **Monday, October 21, 2019** through **Friday, October 25, 2019**. Check local listings. There will be one (1) daily "**KEYWORD OF THE DAY**" each weekday that will be scheduled to appear on-screen once during each show's broadcast.

During the Entry Period, you may enter the KEYWORD OF DAY by navigating the Internet to <http://www.abc7.com> ("**Website**"), and clicking on the "**LA Chargers Mexico Trip Sweepstakes**" image, which will take you to the Sweepstakes homepage. There you will find instructions on the appropriate and acceptable format(s) for submitting your entry electronically. For purposes of these Official Rules, all times and days are Pacific Time. Sponsor's computer is the official time-keeping device for the Sweepstakes.

**Keyword of the Day:** To submit an official Sweepstakes entry, complete the Sweepstakes entry form and enter one (1) correct KEYWORD OF THE DAY in the appropriate field on the entry form. For the avoidance of doubt, entrants may enter ANY Keyword of the Day announced on-air during the Entry Period in order to qualify for this Sweepstakes.

Entrants will receive one (1) entry into the Sweepstakes drawing with the submission of a correctly spelled KEYWORD OF THE DAY. *For example, if hypothetically the "KEYWORD OF THE DAY" is "cat" the entrant has to submit "cat" (correctly spelled) by 11:59pm PT on October 27<sup>th</sup> (capitalization need not be exact).*

**Essay:** In addition to a correct Keyword of the Day, each entrant must submit a written essay of no more than 999 characters telling us why you deserve to win a trip to Mexico City to see the LA Chargers ("**Essay**").

Note: Each entrant will be required on the Sweepstakes entry form to provide Sponsor with a link to entrant's personal Facebook and/or Instagram profiles. Social media accounts must be public.

To enter the Sweepstakes, each Entrant must be a registered member of One-ID ("**Member**").

**Existing Member:** As a Member, you may enter the Sweepstakes by logging into One-ID through the Website with your user name or email address and password and following the entry instructions. If you login to your Member account using Facebook, you will be asked to allow Facebook's "Basic App Permissions," which is required in order to login to your Member account and participate in the Sweepstakes.

**Non-Member:** If you are not a Member, you may become a Member free of charge by visiting the Website and registering by providing the requested information on the registration form through the "sign up" or similar section on the Website. By creating a Member account, you acknowledge your agreement to the Terms of Use (available at <http://disneytermsofuse.com>). Upon becoming a Member and meeting eligibility requirements, you may enter the Sweepstakes by following the instructions.

CLICK THE CHECK BOX SIGNIFYING THAT YOU HAVE READ AND AGREE TO THESE OFFICIAL RULES. IF YOU DO NOT CHECK THE BOX INDICATING YOUR CONFIRMATION OF AND AGREEMENT TO THE ABOVE, YOU WILL NOT BE ENTERED IN THE SWEEPSTAKES AND CANNOT WIN THE PRIZE.

By clicking the "Continue" button to continue with your Entry (as described below), you confirm that you meet the eligibility requirements of this Sweepstakes and agree to these Official Rules. During the registration and entry process, you may be asked to consent to receive promotional and marketing emails from ABC and/or other members of the Walt Disney family of companies or the Prize Provider. Entries must be received during the Entry Period. Entries remain the property of Sponsor and will not be returned or acknowledged.

Sponsors, in their sole discretion, may disqualify any Entry that is deemed duplicative, inappropriate, illegal or offensive, or otherwise not considered valid, and such disqualified entrants will not be eligible to win a prize.

Sponsor can provide no technical support and accepts no responsibility for ensuring the receipt or successful submission of your Entry. Mass Entries or Entries generated by a script, macro or use of automated methods will be disqualified. Sponsor is not responsible for failed, partial or garbled computer transmissions, or for technical failures of any kind, including but not limited to electronic malfunction or damage of any network, hardware or software. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. No responsibility is assumed for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any email or electronic Entry to be received on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to entrant's or any other person's computer related to or resulting from participation in or downloading any materials from this Sweepstakes. In the event of a dispute over an electronic Entry, prize(s) will be awarded to the Entrant submitted by the owner of the Member account. Except as otherwise contemplated by these Official Rules, and to the extent entrants may otherwise elect at the time of Entry, information provided by you for these Sweepstakes is subject to Sponsor's privacy policy located at <https://disneyprivacycenter.com/privacy-policy-translations/english>.

#### **IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED**

**Semi-Finals:** A maximum of seventy-five (75) Entries, will be selected in a random drawing on or about **OCTOBER 28, 2019**. If fewer than seventy-five (75) Entries are received as initial submissions, then all Entries during the Entry Period received shall constitute the "**Semi-Finalist Pool**".

From the Semi-Finalist Pool, ten (10) entrants will be selected as Semi-Finalists by a panels of judges selected by the Sponsor. The Semi-Finalists' Essays will be scored by the Judges on the following criteria: LA Chargers Team Pride (60%) and Degree to Which the Entrant Would Benefit from the Prize (40%). In the event of a tie, the Entrant who scores higher in the "LA Chargers Team Pride" category will advance as a Semi-Finalist.

**Finals:** On or about **October 29, 2019**, a new panel of judges designated by Sponsor shall select three (3) of the Semi-Finalists to become Finalists for the Grand Prize.

To determine the three (3) Finalists, the same scoring criteria and tie-breaker method as described above for the Semi-Finalist selections.

On or about **October 29, 2019** One (1) Grand Prize winner will be selected via random drawing from the eligible Finalists.

Decisions of the judges are final as to all Sweepstakes-related matters. The odds of winning a prize depend on the total number of valid Entries received. Limit one (1) prize per person/household. Potential Semi-Finalists and Finalists will be contacted at the email or phone number listed on the Entrant's Member account. Failure to respond to the initial verification phone call and/or email within forty-eight (48) hours after initial notification or return of the email notification as undeliverable after two (2) attempts may result in disqualification and the selection of an alternate Semi-Finalist/Finalist. Potential prize winner will be required to complete, sign and return within three (3) business days of transmission, an Affidavit of Eligibility, Release and Indemnification, and a Publicity Release where allowed by law, W-9 Form, if applicable and

any other documentation required by Sponsor (collectively, "**Verification Documents**"). Potential winner may be required to submit to a background check, if Sponsor so requires in its sole discretion. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

## **V. PRIZE(S)**

**Grand Prize:** One (1) Finalist shall receive a vacation package to see the LA Chargers in Mexico City, including the following (collectively, the "**Grand Prize**"):

- Roundtrip economy-class airfare for two (2) persons (i.e., winner and a guest) to/from a Los Angeles-area airport and Mexico City (exact route, schedule and seating to be determined by Sponsor, in its sole discretion);
- Double-occupancy (i.e., one (1) hotel room with a maximum capacity of two (2) persons) for three (3) nights at the Hilton in Mexico City (check-in 11/16, check-out 11/19);
- One (1) \$500 gift card; and
- Two (2) tickets to the Chiefs vs. Chargers Monday Night Showdown in Mexico City! on **Monday, November 18, 2019** at 5:15pm PT in Estadio Azteca.

**Grand Prize trip must be taken November 16-19, 2019.**

**Approximate retail value ("ARV") of the Grand Prize: \$2,540.** If the actual value of the Grand Prize is less than the stated ARV, the difference will not be awarded.

Final actual value at the time of booking and travel may be substantially more or less depending on the dates of travel, point of origin and ticket availability. Some restrictions apply. Airline tickets issued in conjunction with the Grand Prize are not eligible for frequent flyer miles, and no code share flights may be used. Federal, state and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of any prize valued at \$600 or more.

## **VI. RELEASES**

By participating, Entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which shall be final in all respects.
