OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

OPEN ONLY TO PERMANENT LEGAL RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA, AND CANADA WHO ARE 21 OR OLDER. VOID IN GUAM, PUERTO RICO, ALL OTHER U.S. TERRITORIES AND POSSESSIONS, THE PROVINCE OF QUEBEC IN CANADA AND WHERE PROHIBITED BY LAW.

- 1. Eligibility:** The **Orlando This Fall Sweepstakes** (“**Sweepstakes**”) is only open to persons who, as of the date of entry: (i) are twenty-one (21) years of age or older; (ii) are permanent legal residents of the fifty (50) states of the U.S., the District of Columbia (“D.C.”) (excluding Guam, Puerto Rico, and all other U.S. territories and possessions), or permanent legal residents of Canada (excluding the province of Quebec), and who are currently physically located and residing therein; and (iii) have either a valid Social Security number, a valid U.S. Individual Taxpayer Identification Number, or a valid Social Insurance Number for Canadian residents. Employees, officers, directors and agents of Buena Vista Television, LLC and Disney Advertising Sales Local (“**Sponsors**”), American Broadcasting Companies, Inc., WABC-TV, *LIVE with Kelly and Ryan* (“**Show**”), Disney ABC Domestic Television, Visit Orlando, Enteractive Solutions Group, Inc. (“**Sweepstakes Administrator**”), participating stations, stations airing the Show, cable operators, multiple service providers, their advertising or promotion agencies, those involved in the production, development, implementation or handling of the Sweepstakes, and any agents acting for the above entities, and their respective parent companies, officers, directors, subsidiaries, affiliates, service providers, prize suppliers, or any other person or entity associated with the Sweepstakes (collectively “**Sweepstakes Entities**”) and members of their immediate families (i.e., a spouse, domestic partner, child, sibling, or parent) and/or persons living in the same household as such persons, whether related or not, are ineligible to win the prize. The Sweepstakes is subject to all applicable federal, state, provincial, territorial, and local laws, regulations, and ordinances.
- 2. How to Enter:** The Sweepstakes begins on Monday, September 30, 2019 at 9:00 a.m. Eastern Time (“**ET**”) and ends on Sunday, November 3, 2019 at 11:59 p.m. ET (“**Sweepstakes Period**”). To enter the Sweepstakes, entrants must visit <https://OrlandoThisFall.com> (“**Website**”) and provide the following information: full name, daytime phone number, and email address. Entrants must also confirm they meet the Sweepstakes eligibility requirements and confirm their agreement to these Official Rules (“**Entry Information**”). In addition, entrants must be registered members of ABC.com, ESPN.com or related websites on the Disney.com registration system (“**Member Account**”) in order to enter. There is no fee to register for a Member Account. Once the Entry Information is submitted, each entrant (if not already logged in) will be prompted to “Log In” to his/her Member Account or non-members will select “Create Account.” Once all of the information is submitted, each entrant will receive one (1) entry into the Sweepstakes (“**Entry**”). **Entries must be received by 11:59 p.m. ET on Sunday, November 3, 2019. Limit one (1) Entry per person/per email address/per day during the Sweepstakes Period.** All required Entry Information must be completed in full, be accurate and valid. No Entry by a group or organization will be considered. By setting up a Member Account and submitting an Entry, each entrant confirms the accuracy and veracity of the statements and information contained therein and acknowledges reading, accepting, and agreeing to these Official Rules and the Sponsors’ Terms of Use located at www.disneytermsofuse.com. If an entrant chose to set up his/her Member Account using Facebook, he/she will be asked to allow Facebook’s “Basic App Permissions,” which is required in order to log in to his/her Member Account and to participate in the Sweepstakes. In addition, he/she must understand he/she is providing his/her information to the Sponsors and not to Facebook and the Sweepstakes is in no way sponsored, endorsed, administered by or associated with Facebook and Facebook is completely released of all liability in this Sweepstakes. The Sponsors have no affiliation with Facebook and no responsibility for (or control of) any matters relating to Facebook or Facebook accounts. The Member Account information and the Entry Information must match the information of the entrant who completed the act of physically entering the Sweepstakes. Entries by the same person in excess of the limits stated herein will be disqualified. Any attempt by an entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations, logins or any other methods other than as described herein, including but not limited to commercial contest/sweepstakes subscription notification and/or entering services, will void that entrant’s

entries and that entrant may be disqualified. Once submitted, Entries become the sole property of the Sponsors and will not be acknowledged or returned. Once an email address has been registered by an entrant, that email address cannot be used by any other person on the Website. Proof of submitting an Entry will not be deemed by the Sponsors as proof of receipt or entry into the Sweepstakes. The Website may not be accessible from all mobile phones, handheld devices, and/or tablets. If a person experiences any issues in attempting to enter, he/she should access the Website and enter from a desktop or laptop computer. If an entrant uses a web-enabled mobile device to participate, data rates may apply (entrants should contact their service provider for data rates/plans). Entrants should use care and not drive or operate machinery while entering the Sweepstakes. The Sponsors' computer shall be the official clock for purposes of the Sweepstakes and all times refer to ET.

- 3. Prize/Odds of Winning: One (1) prize will be awarded.** The winner will receive a 5-day/4-night Orlando Family Vacation for four (4) consisting of: (a) round-trip coach class air transportation for the winner and up to three (3) guests between a major gateway airport near the winner's residence and Orlando, Florida; (b) hotel accommodations for four (4) consecutive nights (single room/quad occupancy/room and tax only); (c) eight (8) single day/single park tickets to winner's choice of Walt Disney World® Resort, Universal Orlando Resort or SeaWorld® Orlando; d) and a full-size rental vehicle for five (5) days (vehicle and rental tax only) subject to eligibility and additional restrictions/requirements listed below (collectively, "Prize"). **The total approximate retail value ("ARV") of the Prize: \$4,999 U.S. dollars ("USD"). Odds of winning the Prize depend on the total number of eligible Entries received during the Sweepstakes Period.** All prize components (airline, departure/arrival airports, hotel, and choice of rental car) to be selected in Sponsors' sole and absolute discretion. Theme park tickets, vouchers, and or certificates cannot be exchanged/redeemed for cash or combined with any other offer and are subject to stated terms and conditions. Choice of theme park tickets to be made by winner, approval of which is to be made by the Sponsors in their sole discretion. The Prize trip must be booked at least thirty (30) days prior to the intended travel dates and travel must be complete by November 15, 2020. If the potential winner is not able to travel within this time frame, he/she may be disqualified, and an alternate potential winner may be selected in Sponsors' sole discretion. The ARV for the Prize may vary depending upon the point of departure, destination, if the winner does not opt to take the allotted number of guests, and price fluctuations in the consumer marketplace based on, among other things, any gap in time between the date the ARV is estimated for purposes of these Official Rules and the date the Prize is awarded or redeemed. The value of the Prize represents the Sponsors' good faith determination of the maximum retail value thereof. Additional compensation will not be provided if the value of the Prize is less than the stated ARV. For the rental car prize component, the winner (or one of his/her guests) must have a valid U.S. and/or Canadian driver's license, be twenty-five (25) years of age or older, have at least one (1) major credit card in good standing, and meet the terms and conditions of the rental agency. The winner will be responsible for any associated additional rental costs (including but not limited to insurance, gas, child seats, GPS, and other vehicle features). The Prize trip is subject to air/hotel/car rental availability, holiday and black-out dates, and all other Prize and travel restrictions, as applicable (in Sponsors' and/or prize supplier's sole discretion). If the closest airport to the winner's residence is in close enough proximity to Orlando, Florida so that, as Sponsors may determine in their sole discretion, a flight is unnecessary, the winner will receive alternate transportation from the Sponsors with no further obligation to the winner. The winner and his/her guests must agree to all airline/hotel/theme park requirements including but not limited to any dress code stipulation (e.g., wearing shoes, shirt), code of conduct, and/or other requirements/conditions in Sponsors' and/or prize supplier's sole discretion. In addition, the winner and his/her guests are required to comply with local laws, customs and regulations during the trip. The winner and his/her guests agree that any associated or inherent risk connected with any activity he/she elects to partake in on the trip is at his/her own risk and Sponsors and the Sweepstakes Entities are not liable for any such activities or any issues resulting from such activities. The Prize may not be sold, traded, transferred, refunded, commissioned, redeemed for cash value or credits for changes, and the prize components may not be substituted except at the sole discretion of the Sponsors. If the winner is unable or unwilling to accept the Prize, or any portion thereof, as stated, the Prize may be forfeited in its entirety at the sole discretion of the Sponsors. If the Prize or a prize component cannot be awarded due to circumstances beyond the control of the Sponsors, a substitute prize of equal or greater retail value may be awarded in Sponsors' sole discretion. If the winner elects to take the trip without the allotted number of guests, the components of the Prize will be awarded in increments/quantities suitable for the actual number of travelers and the winner will not receive any compensation or substitute/alternate Prize or prize

component(s) for the same. The Prize and its prize component(s) cannot be combined/exchanged with any other offer and travel may not qualify for frequent flyer miles. The Sponsors in their sole discretion may substitute the Prize and/or any prize component(s) with one of equal or greater value due to Prize and/or prize component(s) unavailability for any reason. The winner is solely responsible for all costs and expenses of the Prize not specified as included, including but not limited to: travel insurance/premiums; laundry service; spa treatments; meals; excursions/tours; alcoholic beverages; entertainment, local and long distance telephone calls or other communications; internet, wireless services; WiFi; mobile phone roaming fees; service charges; merchandise, souvenirs and/or incidental expenses; upgrades; travel documents; service charges; tips and gratuities; taxes and government fees; transportation between winner's home and the gateway airport or any other unspecified ground transportation; baggage fees; airline seat assignments, upgrades/options, and all other costs and expenses not otherwise mentioned herein. The Sponsors are not responsible for travel delays, cancellations, weather, or for any airline/hotel/car rental policies that may apply and subsequently prohibit or delay winner and/or his/her guests from partaking in the Prize. The winner and his/her guests must present a valid U.S. government-issued photo ID in order to partake in the Prize and meet any other identification or travel-related requirements of the airline/hotel/rental car company (in Sponsors' sole discretion). The winner or his/her guests must have/present at least one (1) major credit card in good standing in order to check-in to the hotel. The winner and his/her guests must travel together on the same itinerary, including the same departure date, destination and return date and are solely responsible for obtaining all necessary valid travel documents (e.g., valid government-issued photo ID and/or Passport) prior to departure. Failure to provide such documents may result in Prize trip cancellation at the airport check-in. In order to comply with the REAL ID Act (<https://www.DHS.gov/Real-id>), adult travelers carrying driver's licenses from a select number of U.S. states may be required to present a valid U.S. passport to travel on a domestic commercial flight in addition to international travel. The Sponsors reserve the right to award the Prize "as-is" and structure travel route, travel dates, and select hotel/vehicle in their sole discretion. Once determined, no change, extension, re-scheduling, or substitution of the Prize trip dates is permitted, except by the Sponsors in their sole discretion. Once Prize travel has been confirmed, any cancellation, change fees or restructuring of the trip are the sole responsibility of the winner. Once the air travel tickets are issued, they are non-refundable, non-endorsable and non-transferable. The Prize restrictions/conditions/requirements stated herein are not all-inclusive and may be subject to additional restrictions/conditions/requirements, which will be stated in the Affidavit/Release (as described below) and/or additional travel, car rental, or boarding related documents issued by the airline/hotel/rental car company. If for any reason whatsoever, the winner is unable to travel after all arrangements have been booked and paid for, the Sponsors shall have no further obligation to such winner and there shall be no compensation or Prize substitution if the winner and/or his/her guests are unable to take the scheduled trip by reason of illness, family emergency, personal events, terrorism, labor strikes, weather, or other acts beyond the Sponsors' control. In the event that a prize component is not available during the time of the Prize trip for whatever reason, the remaining elements of the Prize shall constitute full satisfaction of the Sponsors' prize fulfillment obligation to the winner and no additional compensation will be awarded in lieu thereof. The Sponsors will not replace any lost or stolen theme park tickets, travel vouchers, or certificates (if applicable). Once travel commences, no unscheduled stopovers are permitted. If an unscheduled stopover occurs, the full fare will be charged from stopover point for the remaining segments, including return, of the trip. The Sponsors are not liable for any expenses incurred as a consequence of flight cancellation/delay. All air transportation tickets are subject to the vagaries of flight variation, work stoppages and schedule or route changes. Prize and prize notifications, documentation and travel itinerary will only be shipped to U.S. or Canadian addresses (excluding Quebec). All federal, state, provincial, territorial, or other tax liabilities (including but not limited to income taxes for a U.S. winner or U.S. withholding taxes for a Canadian winner, if applicable) arising from participation in the Sweepstakes or award of the Prize will be the sole responsibility of the winner. If the winner is a U.S. resident, he/she will receive an IRS Form 1099-MISC from the Sponsors for the total ARV, as stated herein, in the calendar year that he/she won. The Sweepstakes Entities are not responsible for any cancellations, delays, diversions or substitutions, or any act or omission whatsoever with respect to the Prize. The Sweepstakes Entities and their respective officers, directors, agents, employees and assigns shall be released and discharged from any and all legal claims, losses, injuries, demands, damages, actions, and/or causes of actions that arise out of and/or in any way related to the Prize, the receipt, use and/or enjoyment of the Prize. Final eligibility for the award of any prize is subject to eligibility verification as set forth in these Official Rules.

- 4. Drawing, Notification and Verification of the Winner:** The winner will be randomly selected from among all eligible Entries received during the Sweepstakes Period on or about Wednesday, November 6, 2019 by the Sweepstakes Administrator, an independent compliance organization located in Burbank, CA (“**Drawing Date**”). The potential winner will be notified by telephone and/or email based on the information associated with such potential winner’s Entry Information. The Sweepstakes Administrator will exert a commercially reasonable effort to reach the potential winner within three (3) business days. Once reached, the potential winner will be required to answer a series of eligibility questions by the Sweepstakes Administrator conducted on the telephone prior to being deemed a potential winner. If a Canadian resident is selected as the potential winner, he/she must correctly answer a time-based mathematical skill-testing question administered during the notification process (without assistance or mechanical/electronic aid) to be eligible for the Prize. In addition, the potential winner will be required to complete, execute, have notarized, and return an original and unmodified Affidavit of Eligibility, a Liability Release and (as applicable) a Publicity Release (collectively, “**Affidavit/Release**”), an IRS Form W-9, a Travel Booking Form, and any other documentation that the Sponsors or Sweepstakes Administrator may require (collectively “**Sweepstakes Documents**”) within five (5) business days after such potential winner’s receipt of the Sweepstakes Documents. Each of the potential winner’s guests will also be required to execute and return an original unmodified Liability Release and (as applicable) Publicity Release (collectively, “**Guest Release**”) and any other documentation that the Sponsors or Sweepstakes Administrator may require within five (5) business days after receipt by the potential winner. If a travel guest is a resident of a jurisdiction that deems him/her to be a minor, his/her parent/legal guardian must sign the Guest Release on his/her behalf and such minor be accompanied by his/her parent/legal guardian who must be deemed the winner or one of the allotted guests. A minor is defined as a resident of Alabama or Nebraska in the U.S., or a resident of the province of Newfoundland and Labrador, New Brunswick, Northwest Territories, Nova Scotia, British Columbia, Nunavut or the Yukon Territory in Canada who is under nineteen (19) years of age, or a resident of Mississippi in the U.S. who is under twenty-one (21) years of age (“**Minor**”). The potential winner will be provided a prepaid FedEx or UPS label for the return of the original Sweepstakes Documents and Guest Releases. By completing and submitting an Affidavit/Release, the potential winner attests to the veracity of the provisions stated therein, including without limitation, compliance with these Official Rules. The potential winner will be disqualified if: (a) he/she cannot be reached within three (3) business days; (b) he/she is found to be ineligible; (c) he/she is not able to answer the mathematical skill-testing question correctly (if a Canadian resident); (d) he/she fails to return the Sweepstakes Documents and up to three (3) Guest Releases within the required time period (as stated above); or (e) he/she does not otherwise comply with these Official Rules. In the event of such a disqualification, an alternate potential winner may be selected in Sponsors’ sole discretion. Any depiction of the Prize in promotional materials or otherwise is for illustrative purposes only.
- 5. General Conditions:** The Sweepstakes is governed by these Official Rules and all applicable federal, state, provincial, territorial, and local laws. By participating, entrants agree to: (i) be bound by these Official Rules and the decisions of the Sponsors and the Sweepstakes Administrator, which are final and binding in all respects; (ii) waive any right to claim ambiguity with the Official Rules; and (iii) indemnify and hold harmless the Sweepstakes Entities from any and all claims, actions, injury, loss, damage or liability resulting or arising from the Sweepstakes. The Sponsors and/or prize supplier(s) are not responsible for any repercussions imposed if the winner or guests exhibit risky or disorderly conduct/behavior or does not comply with local laws, customs and regulations during the trip for any reason. Any personal information supplied by entrants and/or the winner will be treated in accordance with Sponsors’ Privacy Policy located at www.disneyprivacycenter.com. During the entry process, if an entrant opts-in to receive promotional emails and reminder emails from the Sponsors and/or third parties he/she understands that consenting to receive promotional or reminder emails is optional, does not have to be agreed upon in order to be eligible to participate in the Sweepstakes and does not improve any entrant’s chances of winning. The Privacy Policy of any entity asking for consent to send to receive promotional emails and reminder emails will be accessible from the Website. Except where prohibited by law, entry and/or acceptance of the Prize constitutes permission for the Sweepstakes Entities and their respective designees to use an entrant's and/or the winner's name, address (city and state/province/territory), photo, likeness, biographical information, statements, and voice for advertising/publicity/trade purposes worldwide (including posting on the Website or Sponsors’ social media channels) and in all forms of media now known or hereafter devised in perpetuity, throughout the universe, without further notice to or compensation in

connection with the Sweepstakes or the Prize awarded. Personal information collected from Canadians will only be used for Sweepstakes administration purposes unless their express consent has been obtained beforehand. The Sponsors have the right to modify, edit, adapt, electronically alter, use, assign, and/or dispose of Entries however it sees fit and for any purpose without any notice or compensation to an entrant or any third parties. If, for any reason, the Sweepstakes is not capable of running as originally planned due to a virus, malware, bugs, worms or any other causes that impair the administration, security, fairness, or proper play of the Sweepstakes, the Sponsors, in their sole discretion, reserve the right to cancel, suspend, or modify the Sweepstakes, or any portion(s) thereof and, in the event of cancellation, to conduct the drawing, and/or award the Prize from all non-suspect eligible Entries received prior to and/or after (as appropriate) the action taken by the Sponsors or otherwise in a manner that is fair and equitable as determined by the Sponsors in their sole discretion. Notice of such action by the Sponsors will be posted on the Website as well as any applicable social media platforms. The Sponsors reserves the right, in their sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the Sweepstakes; or to be acting in violation of these Official Rules; or to be acting in an unsportsmanlike or disruptive manner; or with intent to annoy, abuse, threaten or harass any other person. Any person attempting to defraud or in any way tamper with this Sweepstakes will be ineligible for the Prize and may be prosecuted to the full extent of the law. In case of a dispute over the identity of an entrant who submitted the winning Entry, the individual associated with the Member Account as determined by the Sponsors in their sole discretion will be deemed the entrant. Said person must comply with these Official Rules, be the person who completed the act of entering, and, in Sponsors' sole discretion, may be required to provide proof of ownership of the Member Account.

- 6. Disclaimers:** The Sweepstakes Entities are not responsible or liable for Entries that are entered by methods other than human means (such as by an automated computer program or any non-human mechanism, entity, bot, or device), in excess of the stated limit, or for Entries that are illegible, late, tampered with, forged, incomplete, misdirected, deleted, damaged, lost, misplaced, stolen, destroyed, dropped, inaccessible, corrupted, jumbled, or otherwise not in compliance with these Official Rules, and such Entries will be disqualified. Each entrant hereby releases each Sweepstakes Entity and its respective agencies, officers, directors, and employees or any other company or person(s) providing the Prize from any and all liability/responsibility with respect to: (a) such entrant's participation in the Sweepstakes (including, without limitation, any property loss, damage, personal injury, or death); (b) human error; (c) incorrect or inaccurate transcription of Member Account information and/or Entry Information; (d) acceptance/possession, use/misuse, and/or defects of the Prize (or prize component(s)) awarded herein; (e) typographical errors in the Sweepstakes promotional material; (f) disputes over answers to mathematical skill test questions in the case of a Canadian winner; (g) incompatibility with internet browsers, mobile, hand-held or tablet devices; (h) cancellations, delays and/or policies that may affect the travel of the winner/guest(s), any change by the air carrier(s), lodging facilities, rental car agency, or other company(ies) or any other person(s) providing any components of the Prize for the winner and his/her guests due to reasons beyond Sponsors' and/or Sweepstakes Entities' control; (i) any technical malfunctions of the telephone network, satellite, computer online system, computer dating mechanism, computer equipment, software, internet service provider; (j) interruption or inability by an entrant or the Sponsors/Sweepstakes Administrator to access the Sweepstakes, the Website, the Entry form, or any online service via the internet due to hardware or software compatibility problems; (k) any damage to entrants' (or any third person's) computer, mobile device and/or the contents of same related to or resulting from any part of the Sweepstakes or from entering or downloading materials/software in connection with the Sweepstakes; and (l) any lost/delayed data transmissions, omissions, interruptions, defects or any other errors or malfunctions even if caused by the negligence of one of the Sweepstakes Entities. Entrants hereby acknowledge that said Sweepstakes Entities have neither made nor are in any manner responsible or liable for any warranty, representation or guarantee, express or implied, in fact or in law, relative to any component of the Prize, including express warranties provided exclusively by any prize supplier of any component(s) of such Prize that are sent or provided along with such Prize. Sweepstakes Entities shall not be liable for any injury, damage, loss, expense, accident, delay, inconvenience, or irregularity that may be caused by or have contributed to: (i) any wrongful, negligent or unauthorized act or omission on the part of a prize supplier (if applicable) or any of its agents, servants, employees, or independent contractors; (ii) any wrongful, negligent or unauthorized act or omission on the part of any other person or entity not an employee of the Sponsors; or (iii) any other cause, condition, or event whatsoever beyond the control of the Sponsors or their parents, subsidiaries, and affiliated companies. The

failure of the Sponsors to comply with any provision of these Official Rules due to an act of God, hurricane, war, fire, riot, strike, earthquake, terrorism, act of public enemies, actions of governmental authorities outside of the control of the Sponsors (excepting compliance with applicable codes and regulations), or other “force majeure” event will not be considered a breach of these Official Rules.

- 7. Governing Law, Jurisdiction, Arbitration:** Any controversy or claim arising out of or relating to (i) the Sweepstakes, (ii) the awarding or redemption of the Prize, and/or (iii) the determination of the scope or applicability of these Official Rules or their enforcement or interpretation shall be governed by and construed in accordance with the substantive laws of the State of California without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state’s laws. Any controversy or claim arising out of or relating to this agreement, its enforcement, arbitrability or interpretation shall be submitted to final and binding arbitration, to be held in Los Angeles County, California, before a single arbitrator, in accordance with California Code of Civil Procedure §§ 1280 et seq. The arbitrator shall be selected by mutual agreement of the Sponsors and the entrant or entrants bringing forth the controversy or claim which to the extent permissible must be brought individually and not as part of a class/group (collectively, the “**Parties**”) or, if the Parties cannot agree, then by striking from a list of arbitrators supplied by the American Arbitration Association or JAMS/Endispute. The arbitration shall be a confidential proceeding, closed to the general public. The arbitrator shall issue a written opinion stating the essential findings and conclusions upon which the arbitrator’s award is based. The Parties will share equally in payment of the arbitrator’s fees and arbitration expenses and any other costs unique to the arbitration hearing (recognizing that each side bears its own deposition, witness, expert and attorneys’ fees, and other expenses to the same extent as if the matter were being heard in court). Each entrant agrees that his/her claim will be resolved individually, exclusively by arbitration, without resort to any form of class action. Each entrant further agrees that any claim/judgment/award in such arbitration shall be limited to actual out-of-pocket costs incurred, including costs associated with participating in the Sweepstakes, and in no event will entrants be permitted to obtain attorneys’ fees or other legal costs; and, under no circumstances, will an entrant be entitled to awards.
