

## ***BLINDED BY THE LIGHT* 2019 OTRC SWEEPSTAKES - OFFICIAL RULES**

### **I. NAME OF SPONSOR(S)**

KABC-TV, ABC Holding Company Inc. (hereinafter referred to as "**Sponsor**").

### **II. ELIGIBILITY**

The *BLINDED BY THE LIGHT* 2019 OTRC Sweepstakes (the "**Sweepstakes**") is open to legal residents of the fifty (50) United States who are at least eighteen (18) years of age or older at the time of entry.

Any individuals (including, but not limited to, employees, consultants, independent contractors, and interns) who have, within the past six (6) months, performed services for Sponsor, other television and radio stations in the greater Los Angeles area, Instagram, or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying a prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, and any person who, within the past ninety (90) days, has been awarded a prize in any sweepstakes conducted by Sponsor, are not eligible to enter or win. Starting at 10:00 am Pacific Time ("PT") on **Tuesday, November 19, 2019** and ending at 11:59 pm PT on **Sunday, November 24, 2019** ("**Entry Period**") you may enter the Sweepstakes by visiting the official On The Red Carpet Instagram page (@otrc) located at <https://www.instagram.com/otrc> ("**OTRC Instagram**"), and fulfilling the requirements listed below.

#### **TO ENTER THIS SWEEPSTAKES, YOU MUST:**

- (1) "Follow" the OTRC Instagram account (@otrc);**
- (2) Find and "Like" the Sweepstakes-themed post on the OTRC Instagram feed ("Sweepstakes Post"); AND**
- (3) Comment on the Sweepstakes Post by tagging three (3) of your friends.**

A properly-submitted comment to the Sweepstakes Entry Post during the Entry Period from followers of the OTRC Instagram Accounts, including a "Like" for the Sweepstakes Post and three (3) tagged friends, shall constitute a valid "Entry" into the Sweepstakes. #### **IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED**

Winners will be selected on or about 10am PT **Monday, November 25, 2019**. Twenty (20) winners will be selected from a random drawing among all eligible Entries received. Potential winners will be notified on or around the date of selection by Instagram direct message. Odds of winning depend on the total number of valid Entries received. Limit one (1) prize per person and only one (1) person per household can win.

Final determination of the winners is always conditional on verification of eligibility and compliance with these Official Rules and procedures.

Failure to respond within twenty-four (24) hours after initial notification message to a potential winner or return of the notification as undeliverable after two (2) attempts may result in disqualification and award of the prize to an alternate winner. Potential winners will be required to complete, sign and return within three (3) business days of transmission, an Affidavit of Eligibility, Release and Indemnification, and a Publicity Release where allowed by law, W-9 Form, if applicable and any other documentation required by Sponsor (collectively, "**Verification Documents**"). If potential winners do not respond to the initial notification within twenty-four (24) hours as set forth above, if Verification Documents are not returned to Sponsor within the specified time period, if the potential winners cannot attend any programming or performances connected with the Sweepstakes on the specified date, if any prize notification or prize is returned as non-deliverable, if a potential winner is found to be ineligible or otherwise not in compliance with these Official Rules, or if a potential winner cannot or does not accept the prize for any reason, prize may be forfeited and such potential winner may be disqualified without compensation of any kind and an alternate winner may be selected in a random drawing (time permitting) from remaining eligible Entries received.

"Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

#### **V. PRIZE(S)**

Twenty (20) winners will each receive a *Blinded By The Light* Blu-ray/digital Combo Pack (the "**Prize**").

The approximate retail value ("**ARV**") of each Prize = **\$35.99**

Total ARV of all prizes being awarded = **\$719.80**

If the actual value of the Prize is less than stated ARV, the difference will not be awarded. All expenses not specifically provided for herein are the winner's sole responsibility. Some restrictions may apply.

Federal, state and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of any prize valued at \$600 or more.

Prize may not be sold, traded, transferred, or refunded. Prize is not redeemable for cash. Sponsor will not replace any lost, mutilated or stolen prizes.
