

ABC13's 25 Days of Christmas Sponsored by Conn's Home Plus OFFICIAL SWEEPSTAKES RULES

The ABC13's 25 Days of Christmas Sponsored by Conn's Home Plus (the "Sweepstakes") is a sweepstakes in which one (1) Prize winner will be randomly selected from all eligible entries. One (1) Prize Winner will each receive two (2) \$500 gift card to Conn's Home Plus .

By participating in the Contest, each entrant agrees that all decisions regarding the Contest, including but not limited to, eligibility determinations, rules and rule interpretations, and the handling of technical difficulties or other errors are at the sole and exclusive discretion of Sponsor and are final, binding and not subject to appeal.

I. NAME OF SPONSORS: KTRK Television, Inc. and Conn's Home Plus ("Sponsor")

The winners will be notified by telephone or e-mail. If a potential winner cannot be reached within Two (2) days of notification of winning, or if he/she is found to be ineligible, or if he/she cannot or does not comply with these Official Rules, winner(s) will be disqualified and an alternate winner may be
