### KENNY CHESNEY CONCERT 2019 INSTAGRAM SWEEPSTAKES - OFFICIAL RULES

## I. NAME OF SPONSOR(S)

KABC-TV, ABC Holding Company Inc. (hereinafter referred to as "**Sponsor**").

### II. ELIGIBILITY
