

WESTFIELD 2020 INSTAGRAM SWEEPSTAKES - OFFICIAL RULES

I. NAME OF SPONSOR(S)

KABC-TV, ABC Holding Company Inc. (hereinafter referred to as "**Sponsor**").

Westfield ("**Prize Provider**")

II. ELIGIBILITY

The Westfield 2020 Instagram Sweepstakes (the "**Sweepstakes**") is open only to legal residents who reside in the Designated Market Area ("**DMA**") of KABC-TV, as determined by Nielsen Media Research Services, and who are at least eighteen (18) years of age or older at the time of entry. The DMA of KABC-TV covers the following counties: Inyo, Kern County-East, Los Angeles, Orange, Riverside County- East, Riverside County-West, San Bernardino, and Ventura counties in the State of California.

Any individuals (including, but not limited to, employees, consultants, independent contractors, and interns) who have, within the past six (6) months, performed services for Sponsor, other television and radio stations in the DMA, Instagram, or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying a prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, and any person who, within the past ninety (90) days, has been awarded a prize in any sweepstakes conducted by Sponsor, are not eligible to enter or win. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three (3) months a year.

III. HOW AND WHEN TO ENTER

NO PURCHASE NECESSARY.

This Sweepstakes shall run from 4am Pacific Time ("PT") on Sunday, November 22, 2020 – 11:59pm PT Sunday, December 20, 2020 (the "**Sweepstakes Period**"), and will be divided into three (3) separate "**Entry Periods**", as further described below.

You may enter the Sweepstakes by visiting the official ABC7 Instagram page (@abc7la), located at <https://www.instagram.com/abc7la> ("**ABC7 Instagram**"), and fulfilling the requirements during any of the three (3) Entry Periods.

Commencing at the start of each Entry Period, one (1) Sweepstakes-themed post ("**Post**") will appear on the official ABC7 Instagram page (three (3) Posts in total throughout the Sweepstakes Period). To enter, entrants must follow the official ABC7 Instagram account, and follow the instructions below:

1. Century City Entry Period: 4am PT on Sunday, November 22, 2020 - 11:59pm PT Sunday, November 29, 2020

To enter the Sweepstakes during the Century City Entry Period, you must:

- 1) "Follow" BOTH the **ABC7 Instagram account (@abc7la)** AND the official **Westfield Century City Instagram account (@WestfieldCenturyCity)**; and
- 2) Comment on the Post by tagging three (3) of your friends.

2. Santa Anita Entry Period: 4am PT Sunday, December 6, 2020 - 11:59pm PT Saturday, December 12, 2020

To enter the Sweepstakes during the Santa Anita Entry Period, you must:

- 1) Follow BOTH the **ABC7 Instagram account (@abc7la)** AND the official **Westfield Santa Anita Instagram account (@WestfieldSantaAnita)**; and
- 2) Comment on the Post by tagging three (3) friends.

3. Topanga Entry Period: 4am PT Sunday, December 13, 2020 - 11:59pm PT Sunday, December 20, 2020

To enter the Sweepstakes during the Topanga Entry Period, you must:

- 1) Follow BOTH the **ABC7 Instagram account (@abc7la)** AND the official **Westfield Topanga Instagram account (@WestfieldTopanga)**; and
- 2) Comment on the Post by tagging three (3) friends.

A properly-submitted comment to a Post during the applicable Entry Period from followers of both the ABC7 and the applicable Westfield Instagram Account, during the dates listed above, and three (3) tagged friends, shall constitute a valid "Entry" into the Sweepstakes. For purposes of these Official Rules, all times and days are Pacific Time. Sponsor's computer is the official time-keeping device for the Sweepstakes.

Limit one (1) Entry per person during each Entry Period (i.e., one (1) Entry per post and no more than three (3) Entries per person during the entire Sweepstakes Period) regardless of the number of Instagram accounts a person may have. Multiple Entries in excess of this limitation may result in disqualification of all Entries by such person. Sponsor, in its sole discretion, may disqualify any Entry that is deemed inappropriate, illegal or offensive, or otherwise not considered to be a valid Entry, and entrant will not be eligible to win a Prize (as defined below).

Neither Sponsor nor Prize Provider can provide any technical support, and accept no responsibility for insuring the receipt or successful submission of your Entry. Sponsor can provide no technical support and accepts no responsibility for ensuring the receipt or successful submission of your Entry. Mass Entries or Entries generated by a script, macro or use of automated methods will be disqualified. Sponsor is not responsible for failed, partial or garbled computer transmissions, or for technical failures of any kind, including, but not limited to, electronic malfunction or damage of any network, hardware or software. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. No responsibility is assumed for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any email or electronic Entry to be received on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to entrant's or any other person's computer

related to or resulting from participation in or downloading any materials from this Sweepstakes. In the event of a dispute over an electronic Entry, prize(s) will be awarded to the owner of the email account, not the name on the entry form. Except as otherwise contemplated by these Official Rules, and to the extent entrants may otherwise elect at the time of Entry, information provided by you for these Sweepstakes is subject to Sponsor's privacy policy located at <https://www.westfield.com/privacy-policy>

IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

On or about 10am PT **Monday, November 30, 2020** one (1) winner will be selected from a random drawing among all eligible Entries received **during the Century City Entry Period.**

On or about 10am PT **Monday, December 14, 2020** one (1) winner will be selected from a random drawing among all eligible Entries received **during the Santa Anita Entry Period.**

On or about 10am PT **Monday, December 21, 2020** one (1) winner will be selected from a random drawing among all eligible Entries received **during the Topanga Entry Period.**

Potential winners will be notified on or around the date of selection by Instagram direct message. Odds of winning depend on the total number of valid Entries received. Limit one (1) prize per person and only one (1) person per household can win.

Final determination of the winner is always conditional on verification of eligibility and compliance with these Official Rules and procedures.

Failure to respond within twenty-four (24) hours after initial notification message to a potential winner or return of the notification as undeliverable after two (2) attempts may result in disqualification and award of the prize to an alternate winner. Potential winner will be required to complete, sign and return within three (3) business days of transmission, an Affidavit of Eligibility, Release and Indemnification, and a Publicity Release where allowed by law, W-9 Form, if applicable and any other documentation required by Sponsor (collectively, "**Verification Documents**"). If potential winner does not respond to the initial notification within twenty-four (24) hours as set forth above, if Verification Documents are not returned to Sponsor within the specified time period, if any prize notification or prize is returned as non-deliverable, if a potential winner is found to be ineligible or otherwise not in compliance with these Official Rules, or

if a potential winner cannot or does not accept the prize for any reason, prize may be forfeited and such potential winner may be disqualified without compensation of any kind and an alternate winner may be selected in a random drawing (time permitting) from remaining eligible Entries received.

In the event of any dispute concerning the identity of any entrant, the Entry will be deemed submitted by the natural person who is the authorized holder of the Instagram account. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

V. PRIZE(S)

Three (3) winners (one (1) winner from each Entry Period) will each receive a \$1,000 Westfield Gift Card (the "**Prize**").

Actual retail value of the Prize = **\$1,000.**

All expenses not specifically provided for herein, including transportation to and from Westfield locations and parking, are the winner's sole responsibility. Some restrictions may apply.

Federal, state and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of any prize valued at \$600 or more.

Prize components may not be sold, traded, transferred, or rescheduled to dates not within the fulfillment period set forth above, or refunded. Prize is not redeemable for cash. Sponsor will not replace any lost, mutilated or stolen certificates.

VI. RELEASES
