

DCAPPELLA 2020 ON THE RED CARPET SWEEPSTAKES - OFFICIAL RULES

I. NAME OF SPONSOR(S)

KABC-TV, ABC Holding Company Inc. (hereinafter referred to as “**Sponsor**”).

II. ELIGIBILITY

DCappella 2020 On The Red Carpet Sweepstakes (the “**Sweepstakes**”) is open to legal residents of the fifty (50) United States who are at least eighteen (18) years of age, or the applicable age of majority in their state of legal residence, whichever is older, at the time of entry.

Any individuals (including, but not limited to, employees, consultants, independent contractors, and interns) who have, within the past six (6) months, performed services for Sponsor, other television and radio stations in the greater Los Angeles area, Instagram, or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying a prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, and any person who, within the past ninety (90) days, has been awarded a prize in any sweepstakes conducted by Sponsor, are not eligible to enter or win (subject to the conditions stated below). Starting at 12:00pm Pacific Time (“**PT**”) on **Sunday, November 22, 2020** and ending at 11:59 pm PT on **Sunday, November 29, 2020** (“**Entry Period**”) you may enter the Sweepstakes by visiting the official On The Red Carpet Instagram page (@OnTheRedCarpet) located at <https://www.instagram.com/ontheredcarpet> (“**On The Red Carpet Instagram**”), and fulfilling the requirements listed below.

TO ENTER THIS SWEEPSTAKES, YOU MUST:

- (1) “Follow” the On The Red Carpet Instagram account (@OnTheRedCarpet);**
- (2) Find and “Like” the Sweepstakes-themed post on the On The Red Carpet Instagram feed (“Sweepstakes Post”); AND**
- (3) Comment on the Sweepstakes Post by tagging three (3) of your friends.**

If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. No responsibility is assumed for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any email or electronic Entry to be received on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to entrant's or any other person's computer related to or resulting from participation in or downloading any materials from this Sweepstakes. IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

Winners will be selected on or about 10:00am PT **Monday, November 30, 2020**. One (1) Grand Prize winner and five (5) secondary prize winners will be selected from a random drawing among all eligible Entries received. Potential winners will be notified on or around the date of selection by Instagram direct message.

Odds of winning depend on the total number of valid Entries received. Limit one (1) prize per person and only one (1) person per household can win. In the event the eligible entry pool is less than the amount of prizes available, Sponsor reserves the right, in its sole discretion, to award prizes to all Entries received, including to such entrants who have won a prize from Sponsor within the past ninety (90) days, but who are otherwise eligible.

Final determination of the winners is always conditional on verification of eligibility and compliance with these Official Rules and procedures.

Failure to respond within twenty-four (24) hours after initial notification message to a potential winner or return of the notification as undeliverable after two (2) attempts may result in disqualification and award of the prize to an alternate winner. Potential winners will be required to complete, sign and return within three (3) business days of transmission, an Affidavit of Eligibility, Release and Indemnification, and a Publicity Release where allowed by law, W-9 Form, if applicable and any other documentation required by Sponsor (collectively, "**Verification Documents**"). If potential winners do not respond to the initial notification within twenty-four (24) hours as set forth above, if Verification Documents are not returned to Sponsor within the specified time period, if the potential winners cannot attend any programming or performances connected with the Sweepstakes on the specified date (if applicable), if any prize notification or prize is returned as non-deliverable, if a potential winner is found to be ineligible or otherwise not in compliance with these Official Rules, or if a potential winner cannot or does not accept the prize for any reason, prize may be forfeited and such potential winner may be disqualified without compensation of any kind and an alternate winner may be selected in a random drawing (time permitting) from remaining eligible Entries received.

In the event of any dispute concerning the identity of any entrant, the Entry will be deemed submitted by the natural person who is the authorized holder of the email address used to create an Instagram account. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

V. PRIZE(S)

One (1) Grand Prize winner shall receive one (1) DCappella "Rockin' Holiday" vinyl record, one (1) Audio Technica AT-LP60X Turntable, one (1) V-MODA Crossfade II Bluetooth Wireless Overear Headphones from Roland and one (1) Boss RC-505 Looper Station from Roland (collectively, the "Grand Prize").

Five (5) prize winners will each receive one (1) DCappella CD and one (1) Spotify gift card (the "Secondary Prize").

The approximate retail value ("**ARV**") of the Grand Prize = **\$894.98**

The ARV of the Secondary Prize = **\$29.99**

Total ARV of all prizes being awarded = **\$1,044.93**

If the actual value of the Prize is less than stated ARV, the difference will not be awarded. All expenses not specifically provided for herein, including transportation to and from the venue, parking and concessions (if applicable), are the winner's sole responsibility. Some restrictions may apply.

Federal, state and local taxes, if any, are the sole responsibility of the winner, who will receive an IRS Form 1099 reflecting the final actual value of any prize valued at \$600 or more.
