MODERN FAMILY 2020 OTRC SWEEPSTAKES - OFFICIAL RULES

I. <u>NAME OF SPONSOR(S)</u>

KABC-TV, ABC Holding Company Inc. (hereinafter referred to as "**Sponsor**").

II. <u>ELIGIBILITY</u>

The *Modern Family* 2020 OTRC Sweepstakes (the "**Sweepstakes**") is open to legal residents of the fifty (50) United States who are at least eighteen (18) years of age, or the applicable age of majority in their state of legal residence, whichever is older, at the time of entry.

TO ENTER THIS SWEEPSTAKES, YOU MUST:

- "Follow" the OTRC Instagram account (@otrc);
- Find and "Like" the Sweepstakes-themed post on the OTRC Instagram feed ("Sweepstakes Post"); AND

IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

Winners will be selected on or about 10:00am PT **Monday, April 13, 2020**. Five (5) winners will be selected from a random drawing among all eligible Entries received. Potential winners will be notified on or around the date of selection by Instagram direct message.

Odds of winning depend on the total number of valid Entries received. Limit one (1) prize per person and only one (1) person per household can win. In the event the eligible entry pool is less than the amount of prizes available, Sponsor reserves the right, in its sole discretion, to award prizes to all Entries received, including to such entrants who have won a prize from Sponsor within the past ninety (90) days, but who are otherwise eligible.

Final determination of the winners is always conditional on verification of eligibility and compliance with these Official Rules and procedures.

V. <u>PRIZE(S)</u>
