

## **CMA Awards Sweepstakes OFFICIAL SWEEPSTAKES RULES**

The ABC13 CMA Awards Sweepstakes (the "Sweepstakes") is a sweepstakes in which one (1) Prize winner will be randomly selected from all eligible entries. One (1) Prize Winner will receive two (2) to The 53<sup>rd</sup> Annual CMA Awards ceremony and broadcast on November 13, 2019.

By participating in the Contest, each entrant agrees that all decisions regarding the Contest, including but not limited to, eligibility determinations, rules and rule interpretations, and the handling of technical difficulties or other errors are at the sole and exclusive discretion of Sponsor and are final, binding and not subject to appeal.

**I. NAME OF SPONSORS:** KTRK Television, Inc. and ABC ("Sponsor")

### **II. ELIGIBILITY:**

- Entrants must be 18 years of age or older at time of entry and be legal residents of the United States who are physically located and residing in counties Harris, Fort Bend, Montgomery, Brazoria, Galveston, Liberty, Waller, Chambers, Austin, San Jacinto, Matagorda, Walker, Polk, Trinity, Grimes, Washington, Colorado, Wharton, Jackson and Calhoun in Texas ("Viewing Area").

From Monday, September 30, 2019 until 11:59 on Monday, October 14, 2019, ABC13.com registered members may enter online at ABC13.com.

- **Existing Member:** As a Member, you may enter the Sweepstakes by logging in to ABC13.com ("Website") with your user name ("User Name") or email address ("Address") and password and following the entry instructions.
- **Non-Member:** If you are not a Member, you may become a Member free of charge by visiting the Website and registering by providing the requested information on the registration form

All winners will be notified on or before October 15, 2019. Odds of winning depend on number of valid entries received. Final determination of winners is always conditional on verification of eligibility and compliance with all rules and procedures. The winners will be notified by telephone or e-mail. If a potential winner cannot be reached within one (1) day of notification of winning, or if he/she is found to be ineligible, or if he/she cannot or does not comply with these Official Rules, winner(s) will be disqualified and an alternate winner may be selected. Prizes not claimed by October 16, 2019 at 5pm will be forfeited. To claim prize, (a) winners must provide proof of age, identity and residency, (b) winners must sign and return affidavit of eligibility/compliance with rules, publicity/liability release and indemnification all within time period specified by station.
