

HALLOWEEN TIME 2019 INSTAGRAM SWEEPSTAKES - OFFICIAL RULES

I. NAME OF SPONSOR(S)

KABC-TV, ABC Holding Company Inc. (hereinafter referred to as "**Sponsor**").

II. ELIGIBILITY

Halloween Time 2019 Instagram Sweepstakes (the "**Sweepstakes**") is open only to legal residents who reside in the Designated Market Area ("**DMA**") of KABC-TV, as determined by Nielsen Media Research Services, and who are at least eighteen (18) years of age or older at the time of entry. The DMA of KABC-TV covers the following counties: Inyo, Kern County-East, Los Angeles, Orange, Riverside County-East, Riverside County-West, San Bernardino, and Ventura counties in the State of California.

Any individuals (including, but not limited to, employees, consultants, independent contractors, and interns) who have, within the past six (6) months, performed services for Sponsor, other television and radio stations in the DMA, Instagram, or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying a prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, and any person who, within the past ninety (90) days, has been awarded a prize in any sweepstakes conducted by Sponsor, are not eligible to enter or win. "Household members" shall mean people who share the same residence at least three (3) months a year.

Starting at 5:00 am Pacific Time ("**PT**") on **Monday, September 16, 2019** and ending at 10:00 am PT on **Monday, September 23, 2019** ("**Entry Period**") you may enter the Sweepstakes by visiting the official ABC7 Instagram page (@abc7la), located at <https://www.instagram.com/abc7la> ("**ABC7 Instagram**"), and fulfilling the requirements listed below.

TO ENTER THIS SWEEPSTAKES, YOU MUST:

- (1) "Follow" BOTH the ABC7 Instagram account (@abc7la) AND the official Disneyland® Instagram account (@disneyland);**
- (2) Find and "Like" the Sweepstakes-themed post on the ABC7 Instagram feed ("Sweepstakes Post"); AND**
- (3) Comment on the Sweepstakes Post by tagging three (3) of your friends.**

IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

Winners will be selected on or about 10am PT **Monday, September 23, 2019**. Twenty-Five (25) winners will be selected from a random drawing among all eligible Entries received. Potential winners will be notified on or around the date of selection by Instagram direct message. Odds of winning depend on the total number of valid Entries received. Limit one (1) prize per person and only one (1) person per household can win.

Final determination of the winners is always conditional on verification of eligibility and compliance with these Official Rules and procedures.

Failure to respond within twenty-four (24) hours after initial notification message to a potential winner or return of the notification as undeliverable after two (2) attempts may result in disqualification and award of the prize to an alternate winner. Potential winners will be required to complete, sign and return within three (3) business days of transmission, an Affidavit of Eligibility, Release and Indemnification, and a Publicity Release where allowed by law, W-9 Form, if applicable and any other documentation required by Sponsor (collectively, "**Verification Documents**"). "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

Twent-five (25) winners will each receive a 4-pack of Disneyland® Resort 1-Day, 1-Park tickets. Disneyland® Resort is located at 1313 Disneyland Dr, Anaheim, CA 92802 (the "Prize").

All tickets must used by June 15, 2020. BLACKOUT DATES AND SPECIAL HOLIDAY HOURS MAY APPLY. Check park website and ticket terms for further details. Please note that Prize tickets do NOT include admission to Oogie Boogie Bash – A Disney Halloween Party.

The approximate retail value ("ARV") of each Prize = **\$596**.

Total ARV of all prizes being awarded = **\$14,900**.

If the actual value of the Prize is less than stated ARV, the difference will not be awarded. All expenses not specifically provided for herein, including transportation to and from the venue, parking and concessions, are the winner's sole responsibility. Some restrictions may apply.
