PAY IT FORWARD 2019 SWEEPSTAKES - OFFICIAL RULES

I. NAME OF SPONSOR(S)

KABC-TV, ABC Holding Company Inc. (hereinafter referred to as "**Sponsor**").

Mathis Brothers Furniture (the "Prize Provider")

II. ELIGIBILITY

NOTE: Because the Pay It Forward 2019 Sweepstakes (the "Sweepstakes") requires the entrant ("Entrant") to nominate a prize recipient ("Nominee"), the eligibility requirements for this Sweepstakes shall apply to both Entrants and Nominees.

The Sweepstakes is open only to legal residents who reside in the Designated Market Area ("**DMA**") of KABC-TV, as determined by Nielsen Media Research Services, and who are at least eighteen (18) years of age or older at the time of entry. The DMA of KABC-TV covers the following counties: Inyo, Kern County-East, Los Angeles, Orange, Riverside County-East, Riverside County-West, San Bernardino, and Ventura counties in the State of California.

Any individuals (including, but not limited to, employees, consultants, independent contractors, and interns) who have, within the past six (6) months, performed services for Sponsor, other television and radio stations in the DMA, Mathis Brothers Furniture, or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying a prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, and any person who, within the past ninety (90) days, has been awarded a prize in any sweepstakes conducted by Sponsor, are not eligible to enter or win. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three (3) months a year.

Entrants cannot nominate themselves, or their immediate family or household members.

III. HOW AND WHEN TO ENTER

NO PURCHASE NECESSARY.

The "Entry Period" for this Sweepstakes shall start at 6:00am PT on Monday, October 7, 2019 and end at 11:59pm PT on Sunday, October 13, 2019 ("Entry Period").

HOW TO ENTER: To enter the Sweepstakes, navigate the Internet to <u>http://abc7.com/</u> ("Website"), locate the Promotions section, and click on the "Mathis Brothers Pay It Forward Sweepstakes" image which will take you to the Sweepstakes home page. There you will find instructions on the appropriate and acceptable format(s) for submitting your entry electronically. For purposes of these Official Rules, all times and days are Pacific Time. Sponsor's computer is the official time-keeping device for the Sweepstakes.

To enter the Sweepstakes, each Entrant must be a registered member of One-ID ("Member").

Existing Member: As a Member, you may enter the Sweepstakes by logging into One-ID through the Website with your user name or email address and password and following the entry instructions. If you login to your Member account using Facebook, you will be asked to allow Facebook's "Basic App Permissions," which is required in order to login to your Member account and participate in the Sweepstakes. **Non-Member:** If you are not a Member, you may become a Member free of charge by visiting the Website and registering by providing the requested information on the registration form through the "sign up" or similar section on the Website. By creating a Member account, you acknowledge your agreement to the Terms of Use (available at http://disneytermsofuse.com). By clicking the "Continue" button to continue with your Entry (as described below), you confirm that you and your Nominee meet the eligibility requirements of this Sweepstakes and agree to these Official Rules. During the registration and entry process, you may be asked to consent to receive promotional and marketing emails from ABC and/or other members of the Walt Disney family of companies or the Prize Provider. Sponsor can provide no technical support and accepts no responsibility for ensuring the receipt or successful submission of your Entry. Mass Entries or Entries generated by a script, macro or use

of automated methods will be disgualified. Sponsor is not responsible for failed, partial or garbled computer transmissions, or for technical failures of any kind, including but not limited to electronic malfunction or damage of any network, hardware or software. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual or associated Nominee who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. No responsibility is assumed for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, or providers, computer equipment, software, failure of any email or electronic Entry to be received on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to entrant's or any other person's computer related to or resulting from participation in or downloading any materials from this Sweepstakes. In the event of a dispute over an electronic Entry, prize(s) will be awarded to the Nominee submitted by the owner of the Member account. Except as otherwise contemplated by these Official Rules, and to the extent entrants may otherwise elect at the time of Entry, information provided by you for these Sweepstakes is subject to Sponsor's privacy policy located at https://disneyprivacycenter.com/privacypolicy-translations/english.

IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

Semi-Finals: A maximum of seventy-five (75) Entries, each for a different Nominee, will be selected in a random drawing on or about **OCTOBER 14, 2019**. If fewer than seventy-five (75) Entries are received as initial submissions, then all Entries during the Entry Period received shall constitute the **"Semi-Finalist Pool**".

From the Semi-Finalist Pool, ten (10) Nominees will be selected as Semi-Finalists by a panels of judges selected by the Sponsor. The Semi-Finalists will be scored by the Judges on the following criteria: Most Compelling Story (30%), Worthiness of the Nominee (40%), and Degree to Which the Nominee Would Benefit from the Prize (30%). In the event of a tie, the Nominee who scores higher in the "Worthiness of the Nominee" category will advance as a Semi-Finalist.

Finals: On or about **OCTOBER 16, 2019**, a new panel of judges designated by Sponsor shall select three (3) of the Semi-Finalists to become Finalists for the Grand Prize.

To determine the three (3) Finalists, the same scoring criteria and tie-breaker method as described above for the Semi-Finalist selections.

On or about **OCTOBER 17, 2019**, the three (3) Entrants who nominated each of the Finalists will be contacted by Sponsor via the phone number or email listed on the Entrant's Member account. If deemed eligible in Sponsor's sole discretion, Sponsor will coordinate with the Finalist Entrants and Nominees to send a KABC TV crew to an agreed-upon location in the DMA to videotape the Finalist Entrants and Nominees sharing their "Pay It Forward" story. If for any reason an Entrant and/or Nominee are not available or are not willing to be available for the taping, Sponsor may, in its sole discretion, disqualify said Finalist and another Finalist will be selected (time permitting) using the judging criteria set forth above.

On or about **OCTOBER 18, 2019**, one (1) Grand Prize winner will be selected via random drawing from the eligible Finalists. The two (2) remaining Finalists shall be declared Runner-Up Prize winners (as further described below).

The two (2) Runner-Up Prize Winners will be announced on or about **OCTOBER 28 – OCTOBER 30, 2019**. The Grand Prize winner will be announced on or about **NOVEMBER 1, 2019**. All

prize winners are scheduled to be announced on-air during the ABC7 Eyewitness News broadcast on or about 6:00am Pacific Time.

Decisions of the judges are final as to all Sweepstakes-related matters. The odds of winning a prize depend on the total number of valid Entries received. Limit one (1) prize per person/household. Potential Semi-Finalists and Finalists will be contacted at the email or phone number listed in the Entrant's submitted entry materials. Failure to respond to the initial verification phone call and/or email within forty-eight (48) hours after initial notification or return of the email notification as undeliverable after two (2) attempts may result in disgualification and the selection of an alternate Semi-Finalist/Finalist. Runner-Up Prizes: The two (2) runner-up Finalists will each receive a \$1,000 Mathis Brothers gift card, plus an additional check for \$300 to assist in the payment of any tax liability imposed in conjunction with the prizes (each, a "**Runner-Up Prize**").

The actual retail value of the Grand Prize is \$13,000. The actual retail value of each Runner-Up Prize is \$1,300.
