**OFFICIAL RULES**

To enter and participate in this Sweepstakes, you must agree to and abide by these Official Rules.

IF YOU DO NOT CHECK THE BOX INDICATING YOUR AGREEMENT TO THE ABOVE, YOU WILL NOT BE ENTERED IN THE SWEEPSTAKES AND CANNOT WIN A PRIZE.

The random drawing will be conducted by Administrator, an independent judging organization, whose decisions are final and binding in all respects related to the Sweepstakes.

- 6. Winner Notification:** Potential Prize winners will be notified by e-mail on or about April 24, 2023. Failure to respond to the initial notification e-mail within three (3) business days after transmission to the potential winner or return of the e-mail notification as undeliverable after two (2) attempts will result in disqualification and award of the prize to an alternate winner. Potential winner will be required to complete, sign and return within three (3) business days of transmission, an Affidavit of Eligibility, Release and Indemnification, W9 Form and a Publicity Release where allowed by law and any other documentation required by Sponsor or Administrator (collectively, the "Prize Claim Documents").
